

**PPSI 2023 Participant Waiver/Release of Liability**

MUST BE SIGNED BY ALL PARENTS/LEGAL GUARDIANS OF PARTICIPANTS AND ALL ADULT PARTICIPANTS (including caregivers, faculty, and teachers observing and taking training) in order to attend PPSI

I understand that PPSI may take photographs and/or videos of institute participants and activities. I agree that PPSI shall be the owner of and may use such photographs and/or videos relating to the promotion of future institutes. I relinquish all rights that I may claim in relation to the use of said photographs and/or videos.

I voluntarily agree to release, remise, acquit, forever discharge, and hold harmless Florence (Flori) Muller, any member of the Muller household, Peaks to Plains Suzuki Institute (PPSI) (its board, officers, directors, employees, and agents), Stargate School (its board, officers, directors, employees, and agents) from any and all claims, lawsuits, causes of action, demands, liabilities, losses, costs and expenses of any kind or nature arising out of or related to exposure to or transmission of any and all illnesses, injuries, damages, sickness, death, expenses or other losses arising in any way from my/our attendance at and participation in each and every PPSI Event or any other activity, including, but not limited to, exposure to COVID-19 or any sicknesses, viruses, bacteria or injuries incurred on property while attending PPSI.

I understand that registration fees are non-refundable. Additional fees (additional t-shirt, harp tuning fees, extra enrichment class fees, teacher SAA and course materials fees) are non-refundable. Because of the Institute's commitment to faculty and facility arrangements, applicants who withdraw on or after May 1, 2023 will forfeit all tuition and fees. Half of the tuition is refundable if withdrawal is communicated in writing to the director on or before April 30, 2023. The ONLY exception to this policy is due to positive COVID (see below).

I have read and commit to adhere to the COVID Requirements/Procedures as stated on the Covid Waiver. If I am positive for COVID and must quarantine in the days leading up to July 17, 2023, I will notify the director of my positive covid test and withdraw from PPSI. I will have my doctor scan and email the director a signed letter on their office official letterhead stating the date of my positive covid test, the quarantine dates resulting and the date in which your quarantine should end explaining that you are therefore unable to attend PPSI. Upon proof of a positive covid test, a doctor's recommendation that you can not attend the Institute because of positive COVID and quarantine dates conflicting with PPSI dates, you will have half of your tuition refunded. Please note that the Registration fee as well as other fees (such as t-shirt, extra enrichment etc.) are non-refundable.

If I am positive for COVID once the Institute begins on July 17, 2023, I must immediately notify the director and withdraw from the Institute. I understand that I will forfeit all tuition and fees.

## COVID WAIVER

Ensuring the health and safety both within and outside our PPSI community is a priority and only works when we all do our part, together. In order to take part in an in-person PPSI program, families, teachers and faculty who will be in person on campus are required to read and adhere to following these specific COVID related requirements/procedures. There is a line item on the Participant Waiver stating that you have read, agree and accept to the following terms and conditions presented in this Covid Waiver document as part of the Participant Waiver/Release of Liability.

My family and I understand and accept that there are risks inherent in being physically present on a campus community during a global pandemic, but by taking care of others and myself, we can contribute to public health and safety.

Requirements/Procedures for in-person instruction at PPSI

Prohibitions on Attendance. Attendee(s) acknowledge and agree that no person may enter the facility or attend PPSI if that person is positive for COVID or has symptoms including but not limited to a cough, fever, congestion, sore throat, shortness of breath, difficulty breathing, flu-like symptoms, gastrointestinal upset, or experienced a recent loss of taste or smell.

Illness: Anyone in your family (students, parents, siblings, etc.) presenting ANY symptoms of illness (this includes all COVID symptoms as well as symptoms of ANY other illness- examples but not limited to fever, cough, runny/stuffy nose, sore throat, stomach ache, diarrhea etc.) will be asked to leave PPSI immediately and will forfeit with no makeups or refunds.

Exposure COVID-19: If you or a family member in your household have recently been in contact with someone who was diagnosed with COVID or currently has COVID or has COVID symptoms, you must report this to the Director. If you or a family member are quarantined from a possible exposure, you must report that to the Director. If you or a family member are currently awaiting COVID test results, you must report that to the Director as well as the results of the test.

Assumption of Risk: Regardless of adherence to recommendations and following procedures, there is a risk of COVID exposure whenever an individual enters into a public space, house or building with other people. By attending PPSI at Stargate School, 14530 Washington St, Thornton, CO 80023, the Attendee(s) acknowledges and agrees that the Attendee(s) is/are assuming the risk of COVID exposures.

The Attendee(s) understand that the contents of this document will remain in effect until further notice and that the Attendee(s) AND their family will follow the requirements/procedures in this document. Failure to follow any part of this document will result in an executive decision on Attendee(s) continued attendance at PPSI and forfeiture of tuition and fees.
